PRECIOUS PETS BOARDING AGREEMENT

- I am the owner or person responsible for (pet's name)_____ and have the authority to execute this agreement. I agree to pay for all fees rendered to said pets.
- I understand that Precious Pets, it's employees and officers will exercise due care to protect the health and safety of my dog while in their care. In the event that my dog becomes ill or sustains an injury, I authorize Precious Pets and it's representatives to obtain medical treatment for (name of dog)_____. I understand that every effort will be made to contact me in such an event. I request that Precious Pets or the attending veterinarian contact me. I agree to reimburse Precious Pets for any and all expenses incurred for the medical treatment of my dog. Payment will be made upon pick up.
- I understand that Precious Pets is an open play environment, and because of this, there are inherent risks, which even when closely monitored, may result in the following:
 - A: Transfer of communicable illness such as, but not limited to, "kennel cough", also known as Bordatella virus (even if vaccinated it is still possible to contract kennel cough), "puppy warts", also known as canine papilloma virus.
 - B: Injuries, usually benign, such as broken nails, sore pads, puncture wounds abrasions and cuts, particularly in short hair breeds, etc.
 - C: Behavioral problems
- Precious Pets and their staff will not be held liable for any health or behavioral problems that develop in my dog(s) attendance and participation at Precious Pets.
- I am solely responsible for any harm, including to other dogs, the the employees or invitees or Precious Pets, or to equipment or other property caused by my dog while they are attending Precious Pets.
- I understand if I own 2 or more pets I want lodged in one enclosure that it may lead to aggression resulting in injury or death. I WANT MY PETS LODGED TOGETHER AND ACCEPT THIS RISK. Together_____ Separate _____.
- I am aware that my pet's vaccinations must be current in accordance with Precious Pets policy and that I am responsible to provide adequate immunization records. In the event this is not available and/or any immunizations are not current I authorize vaccination(s) and agree to pay for that service.
- To the best of my knowledge my pet(s) have not been exposed to kennel cough, rabies or other contagious diseases within 30 days prior to check in.
- I agree to pay for the dates reserved for my said pets above, regardless of early pick up.
- I agree to inform Precious Pets if I am unable to make the reservation check out date. All pets left longer that 2 weeks without renewed checkout information will be considered abandoned. These pets will become property of Precious Pets. I understand abandonment will be prosecuted to the fullest extent of the law and agree to pay all associated court costs, legal fees and lodging fees.
